Item 1.01 Entry into a Material Definitive Agreement.

On February 13, 2023, The BeBop Channel Corporation will enter into a Material Definitive Agreement to acquire Madavor Media, LLC on February 15, 2023. Madavor, a private company, is a print and digital media company which produces the renowned Jazz Times Magazine, Outdoor Photographer, the Women Create brands and other titles in various areas of interest which include a robust advertising and subscriber base.

Madavor will be acquired from Zilpin Group, LLC with which The BeBop Channel Corporation had no prior relationship or affiliation, for 2.0million shares of BeBop Common stock (including shares for certain key executives of Madavor), a \$3 million Seller note issued to Zilpin, and certain other consideration.

Madavor, founded in 2004, has 32 employees and had gross revenues of \$5.2 million for the 11 months ending November 2022 and projects gross revenue of \$6.5 million in 2023

BeBop had just \$350,000 in revenue in its most recent fiscal year ending June 30, 2022 published on OTC Markets, representing a 1,800% increase in projected revenue for 2023.

Madavor will become a wholly-owned subsidiary of BeBop which has plans to expand the experience of Madavor's subscriber base into video programming and live events creating a strong value for its print and digital advertisers which are Arts and Enthusiasts related.
